

ORDINANCE NO. 21-07-02

AN ORDINANCE CANCELLING STANDING COMMITTEE MEETINGS AND ESTABLISHING COMMITTEES OF THE WHOLE MEETING DATES FOR 2021

WHEREAS, Section 2.02(a) of the Open Meeting Act, 5 ILCS 120/2.02(a) requires that every public entity shall give public notice of the schedule of regular meetings at the beginning of each calendar or fiscal year;

WHEREAS, the Village Board of the Village of Round Lake Beach previously established all meeting dates by Ordinance No. 20-12-05;

WHEREAS, the Village Board desires to cancel the rest of the standing committee meetings established by Ordinance No. 20-12-05 and to establish a regular schedule of meetings for the Village's committee of the whole;

WHEREAS, the Village Board, by this Ordinance, hereby sets the schedule of the regular meetings of the committee of the whole for 2021.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF ROUND LAKE BEACH, LAKE COUNTY, ILLINOIS, in the exercise of its home rule powers as follows:

SECTION 1: The above state recitals are incorporated by this reference.

SECTION 2: The scheduled meetings of the standing committees set forth on Exhibit A which is attached hereto are all canceled.

SECTION 3: The schedule of meetings of the committee of the whole which is attached hereto as Exhibit B is hereby adopted as the official meeting schedule of the committee of the whole for the rest 2021. All meetings shall take place at Round Lake Beach Village Hall, 1937 North Municipal Way, Round Lake Beach, Illinois at 6:00 p.m. on the days and dates and set forth in Exhibit B.

SECTION 4: Nothing in this Ordinance shall be construed to prevent the Village Board from canceling a regular meeting or a committee or the whole meeting or changing the date, time, or location of any meeting, or from any other Village Board Committee, Board or Commission from canceling a regular meeting or changing the date, time, or location of any regular meeting, provided that notice of the changed date, time or location will be given in accordance with all applicable provisions of the Open Meetings Act.


SECTION 5: If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

SECTION 6: All Ordinances in conflict herewith are hereby repealed to the extent of such conflict. Except as repealed by this Ordinance, the balance of Ordinance No. 20-15-05 shall remain in full force and effect and in accordance with the schedules set forth therein.

SECTION 7: This Ordinance shall be in full force and effect from after its passage and approval.
